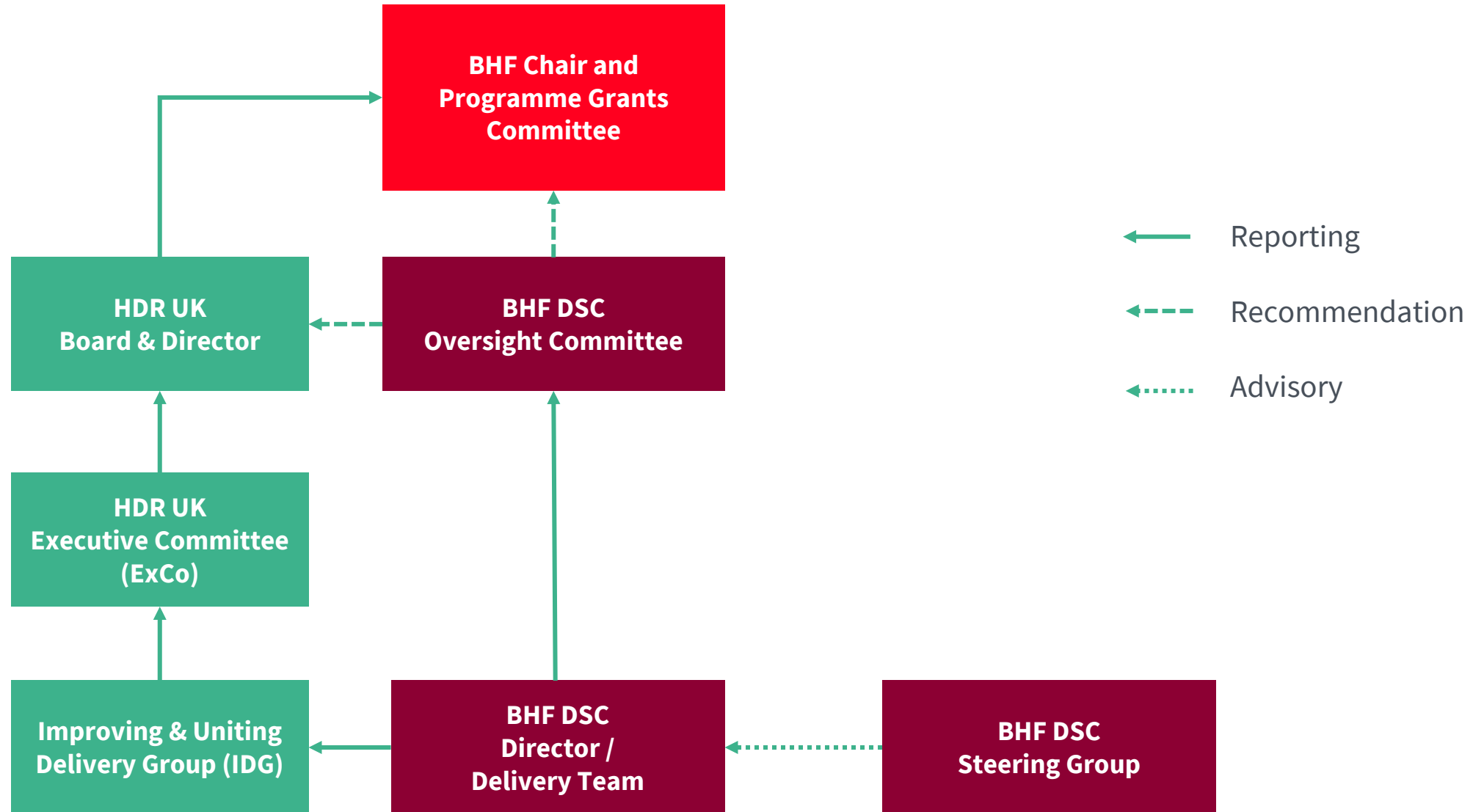


BHF Data Science Centre Governance Structure
