Working with HDR UK – a briefing for AMRC charity members

As users of data to create insights for policy work, and as funders of research that generate data, there are many ways that AMRC members could work with HDR UK. Here we have set out some current opportunities, but we welcome discussions to understand your ambitions for health data and how we could work collaboratively to delivery them.

1. Support wider discovery and access to datasets relevant to your disease area

The <u>Health Innovation Gateway</u> is a portal enabling researchers and innovators in academia, industry and the NHS to search for and request access to a wide range of datasets. Getting data funded by your charity onto the Gateway can increase its findability and wider use by other researchers, supporting open science and increasing impact and utility of research you've funded.

- Identify datasets in your portfolio that have wide potential for reuse and connect the data owners
 with HDR UK to explore making the dataset findable on the Gateway. This can be done at any
 stage of the research lifecycle, including making it a condition of funding.
- Work with HDR UK to create a <u>Collection of resources</u> that are relevant to your disease area. We can work together to promote its use to a wide community of researchers.
- Join us for one of our Gateway Open door sessions to learn more they are held every month Gateway Open Door and Q&A: November HDR UK.

Please contact gateway@hdruk.ac.uk to continue the discussion. The Gateway functionality is growing all the time to support federated data discovery across multiple platforms, a standardised data access request process, and a suite of other data science tools.

2. Explore what a Health Data Research Hub could do for your field

A <u>Data Research Hub</u> takes a national leadership role in curating and improving the quality and access of data in disease and topic areas.

There are nine Hubs delivered in partnership with HDR UK, and we are working on a range of other
Hubs in development. HDR UK has developed a suite of materials and resources to support the
creation of new Hubs and can support the efficient design and set up of a data Hub. We welcome
partnership with charities in exploring and designing Hubs in areas of unmet need.

3. Promote capacity building and training in your community

4. Join the UK Health Research Alliance to shape health data ecosystem

Charities wishing to play an active role in shaping the health data research ecosystem could join the <u>Alliance</u>, convened by HDR UK. Through different workstreams, the Alliance develops and co-ordinates the adoption of tools, techniques, conventions, technologies, and designs that enable the use of health data in a trustworthy and ethical way for research and innovation. All Alliance members agree to work together through an <u>agreed set of principles</u>.

5. Public and patient involvement and engagement
